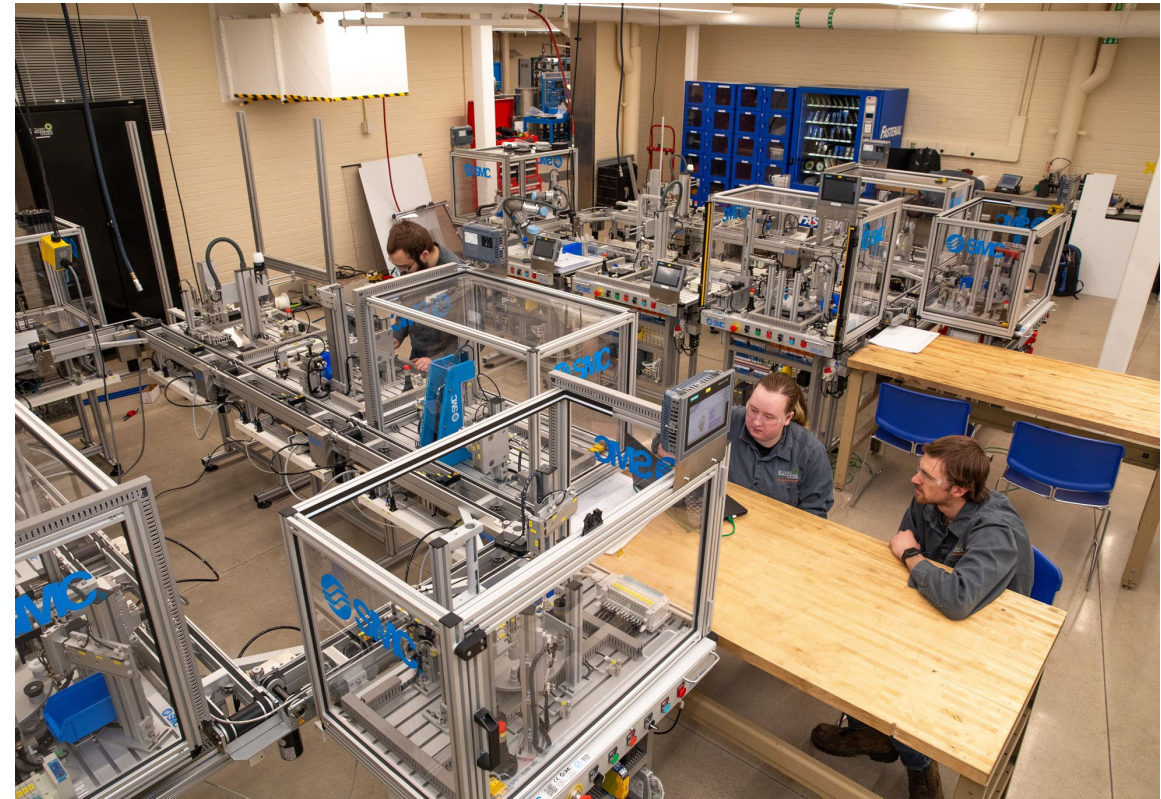

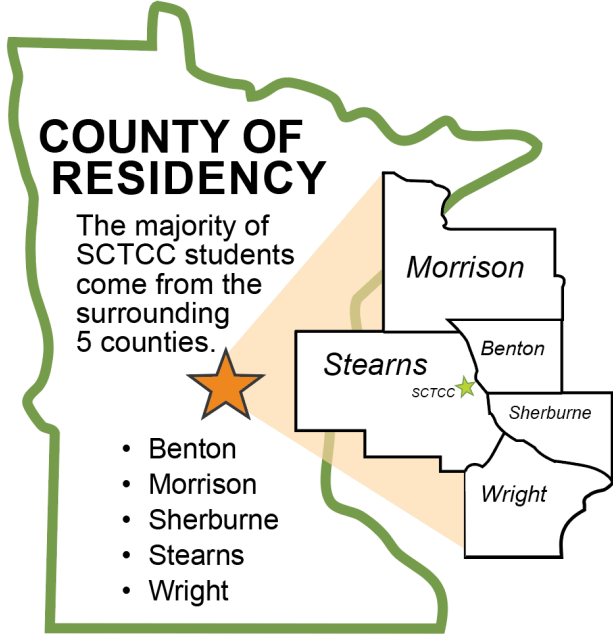

Post-Secondary Enrollment Option Students (2023)



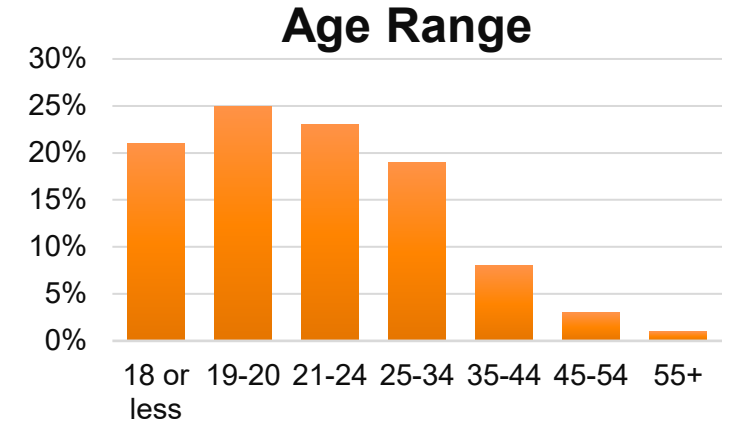

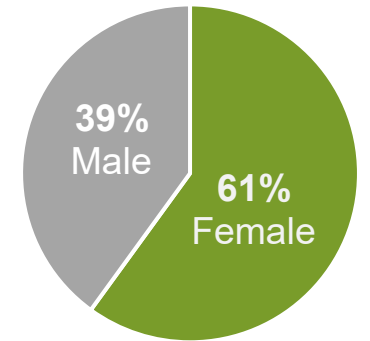
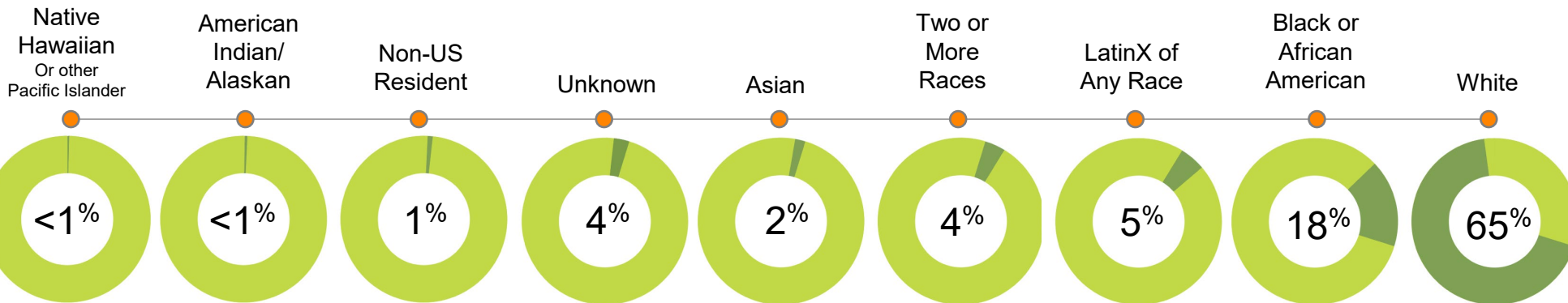

Race/Ethnicity



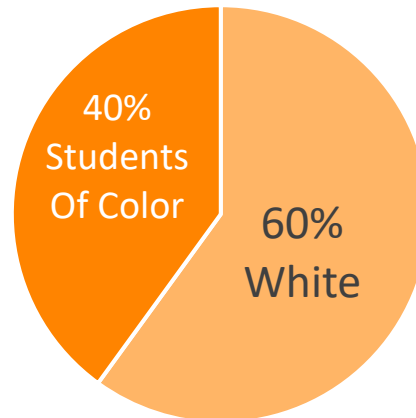
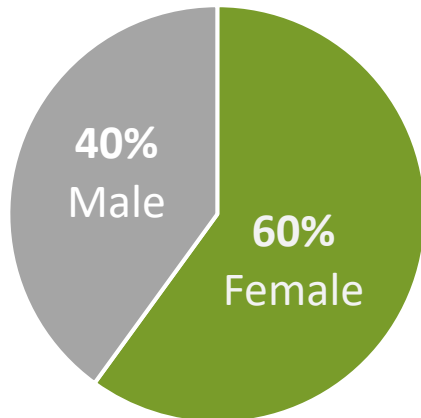

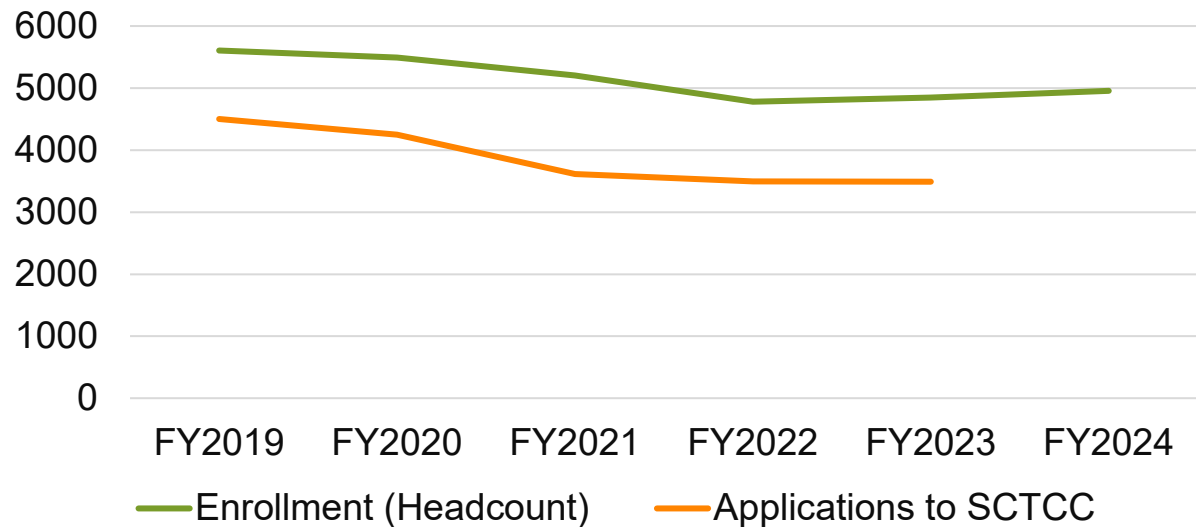
